



## **CLEARWATER PLANNING COMMISSION BOARD APPLICATION**

### **POWERS AND DUTIES**

The powers and duties of the Planning Commission are outlined in Minnesota Statutes Chapter 462. Generally, it is the responsibility of the Planning Commission to review and interpret the city's Comprehensive Plan and Zoning Ordinances and advise the City Council on matters subject to their review under these planning documents. Planning Commissioners have broad responsibility to advise the City Council on land use requests to help Council Members make decisions that are in the best interests of the residents of the City of Clearwater.

The Planning Commission is comprised of five voting members appointed by the City Council. Members serve staggered terms of up to three years. Members must be residents of the City of Clearwater or one Member may be a resident of an adjacent township who lives within a five-mile radius of City Hall. A City Council Member serves as one Member.

The Planning Commission normally meets the second and fourth Tuesdays of each month at 7:00 p.m. at Clearwater City Hall. Meetings may be cancelled if there is a lack of Commission business.
