Select Your Rental

Pavilion Rental (Concession Area Included)

- **Security Deposit: \$100. Deposit is required to reserve the date.**
- **Resident Fees:** \$50.00/day rental fee (including tax) + \$100 security deposit
- **Non-Resident Fees:** \$75.00/day rental fee (includes tax) + \$100 security deposit

Field/Course Reservation - Single Date

- **Rental Fees (Resident or Non-Resident):** \$35.00/day rental fee (includes tax)

Field /Course Reservation – Per Season (Pavilion & Concession Area Included)

- **Resident Fees:** \$75.00 season rental fee (includes tax)
- **Non-Resident Fees:** \$100.00 season rental fee (includes tax)

Payment Deadline: All rental fees must be paid at least 15 days before the event. Door access codes will not be provided until full payment is received.

Cancellations: A minimum of 14 days’ notice is required. Failure to cancel within this timeframe will result in forfeiture of the rental fee.

Deposit Refund: The security deposit will be refunded within 30 days after the event, provided the facility is left clean and undamaged.

- Renter must be at least 21 years of age.
- Rental facilities hours are 7:00 am to 11:00 pm.
- Place litter in dumpsters or waste receptacles provided.
- Overnight camping is not permitted.
- Glass containers are not allowed in park area.
- No firearms or explosives allowed (including firecrackers and BB guns).
- Bathrooms are open May 15-October 15.
- Rental agreement applies to rental only; all other amenities remain open to the public.

CLEANING – PAVILION RENTALS

- Wipe down all tables and counters. Bring your own solution for wiping off tables and surfaces.
- Empty all garbage and place it in trash cans outside the building.
- Remove all food and personal belongings from the building.
